

**Regarding payment of school dues**

Dear Parents

Greetings to you all with a belief that you and your family are fine and in good health. During these challenging times, please continue taking precautions to fight against the virus and we shall certainly sail through. We are grateful to all the parents for their support and cooperation for the online teaching-learning of our students.

We reiterate our commitment for working together as a team for the betterment of our students and the society at large.

As you are already aware, since April 2020, the schools were allowed to collect tuition fees only.

Now, the Hon'ble High Court of Delhi vide its judgments dated 31.05.21 and 07.06.2021 has permitted schools to collect the following charges, in addition to the tuition fee for the academic sessions 2020-21 and 2021-22:

- 1) **For the academic session 2020-21**- Annual Charges and Development Fee by providing deduction of 15% on both these charges.

The amount so payable by the parents shall be paid in six equal monthly installments starting from 10.06.2021.

- 2) **For the academic session 2021-22** - Grant 15% concession on the Annual Charges and Development Fee till further information.

In light of the above, the school has prepared two bills for the month of June, 2021 - one for Tuition fee, Annual Charges & Development Fee of April to June, 2021 and another for the first installment of arrears for Annual Charges and Development Fee for the session 2020-21.

We hope you understand that tuition fee alone is insufficient to meet the expenses of the school. The timely payment of fees by you shall make a huge difference and strengthen the foundation of our partnership in imparting quality education. Hence, we expect your cooperation for the early payment of school dues.
