Steps of Taking E-Pledge

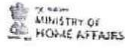
- Step 1:- Go to Link :- <https://pledge.mygov.in/fightagainstdrugabuse/>
- Step 2:- Now click on "Take pledge" Button. This will open a new page.
- Step 3:- To take pledge enter your basic details – e.g. Name, Gender, DOB, Mobile No. etc
- Step 4:- After filling the basic details, click on " Proceed for language Selection "
- Step 5:- Select the language from drop down menu Either "Hindi" or "English " and click on "Read Pledge" Button
- Step 6:- Now Read the Pledge as it is shown on the screen
- Step 7:- After reading the Pledge click on " I Pledge" Button
- Step 8:- Enter the OTP received on your registered Mobile Number & Click on "Submit" Button
- Step 9:- Your certificate will appear on the screen. 5 options are given under the certificate
 1. "Send Certificate to your mobile":- Click this Button if you want to receive certificate in your mobile.
 2. "Send certificate! Pledge to your Email":- Click this Button if you want to receive certificate in your email.
 3. "Print| Download Certificate" :- Click this Button if you want to download, print or save certificate in your computer.
 4. "Share with Facebook":- Click this Button if you want to share certificate on Facebook.
 5. "Share with Twitter":- Click this Button if you want to share certificate on Twitter.
