Sub: Regarding Conducting Classes in Hybrid Mode for Students of All Classes.

The Commission for Air Quality Management in National Capital Region and Adjoining Areas in its order F. No. 120017/27/GRAP/2021/CAQM-1112 (DT) dated 25/11/2024 (Copy enclosed) has stated as under:

"Clause 11 of GRAP Stage-III, Clause 5 of GRAP Stage-IV and Clause 8 of GRAP Stage-IV (to the extent it relates to colleges / educational institutions) are relaxed to the extent that State Govts. in the NCR and the GNCTD shall ensure that all classes upto 12th Standard in schools and those in colleges / educational institutions are conducted in a "Hybrid" mode i.e., both in "physical" and also in an "online" mode, wherever online mode is feasible, in the territorial jurisdiction of the NCT of Delhi and in the districts of Gurugram, Faridabad, Ghaziabad and Gautam Buddha Nagar in the NCR. The option to exercise online mode of education, wherever available, shall vest with the students and their guardians."

Accordingly, all Heads of Schools of Govt., Govt. Aided, Unaided Recognized Private Schools of DoE, NDMC, MCD and Delhi Cantonment Board are directed to ensure compliance of the above orders with immediate effect until further orders.

All the Heads of Schools are hereby further directed to disseminate this information to the parents and guardians of the students immediately.
